At the Saskatchewan Council for International Cooperation we are incredibly grateful to have the talent and time of so many! This past year, we engaged thousands of people in Saskatchewan on Sustainable Development Goals (SDGs), Feminist International Assistance Program (FIAP), and Gender Equality. National Coalition

SCIC is one of eight Provincial and Regional Councils for International Cooperation that together make up the Inter-Council Network (ICN). Collectively, we represent more than 350 diverse civil society organizations (CSOs) across Canada. The ICN provides a national forum in which SCIC can bring regional knowledge and priorities from Saskatchewan forward in support of identifying collective actions for improved effectiveness. Two of these collective initiatives are the Fund for Innovation and Transformation (FIT), and Spur Change. Each of these national ICN initiatives were continued during the 2023–24 program year.





























Global Citizenship Education

Global Citizenship is a way of understanding how the world works and the links between our own lives and those of people throughout the world. It is a worldview that values social justice, equity, empathy, compassion, a respect for diversity and interconnectedness, and a belief that people can make a difference, and have the responsibility to do so. It is a way of acting that includes critical thinking, challenging injustice, and exercising political rights.

InSight 360°

The InSight Virtual Reality program was run in Y5 as a way to extend the reach of the InSight program beyond the 360° cylinder showings in Y3 and Y4 and to increase the capacity of educators in Saskatchewan further. The InSight Virtual Reality program promoted and offered teacher resource modules, toolkits, and cardboard virtual reality goggles to support educators leading lessons and activities related to Gender-transformative and/or responsive stories of women and girls in the Global South. We had a total of 544 participants engage with the InSight Virtual Reality program.




Resources for Educators

Enabling educators to lead informative and engaging lessons on global topics is an important aspect of SCIC's Global Citizenship Education (GCE) program. SCIC continues to curate valuable and practical lesson plans and classroom activities for teachers to further increase the capacity of educators in Saskatchewan. Our latest offerings include French translations of SCIC's GCE Module 1 on Transforming Charity into Solidarity and Justice and Module 3 on Global Citizenship in the Classroom.


Educator Reading Circle

SCIC held three Reading Circles in 2023–24. The books read included, Daylight Come, Around the World in the Blink of an Eye: a truly global picture book, and They Called Me a Lioness. The 39 Educators were from across Saskatchewan and met virtually to discuss the book, share opinions and exchange resources, while discussing how to use the book as a resource in the classroom. With a lineup of expert presenters and guest speakers, the Reading Circles sparked engaging conversations on topics like decolonization, power and privilege, anti-racism, democracy, feminism, war and conflict, and Indigenous environmental knowledge. By joining, educators connected with a community of peers, gain insights, and become thought leaders in their schools and districts.









Network

SCIC believes that when we recognize our global interconnectedness and work together, we can contribute to global efforts to reduce global poverty and inequality. Our Partnership Framework for the network focuses on two guiding themes: Canada's Feminist International Assistance Policy (FIAP) & the Sustainable Development Goals (SDGs).

This year, we engaged with 32 members and 105 partners across Saskatchewan. We are most proud of our programming efforts to build the capacity of Saskatchewan organizations in SDGs and FIAP, along with project implementation planning, fundraising, and gender equality

The objectives are to improve both the capacity and knowledge of the global justice sector through networking and knowledge-sharing. SCIC organizes collaborative events to share knowledge and improve skills and capacity, to enhance our collective impact.

In 2023/2024, SCIC hosted multiple workshops, discussion series, and other events to support learning and skills development in our sector.

Youth

SCIC continually seeks to engage and empower youth with the knowledge and skills they need to participate in significant global challenges. Collaborating with 18-35 year old Saskatchewan youth alongside youth-centered organizations in the province, SCIC engages with these two key demographics to inform topics that are important to youth. From there, SCIC works together with both youth and youth-centered organizations to facilitate leadership opportunities such as organizing youth-led events.

Based on youth feedback and engagement input, Y5 saw a variety of SCIC youth leadership and empowerment initiatives that specifically centered on: art in relation to global justice, youth leadership and youth voices; climate action strategies and mobilizing; gender equality in relation to education, agriculture, and climate; community and partnership capacity building; Indigenous land rights in Canada and the Global South; as well as ethical international development practices in conflict zones of the Global South.

Generating Momentum & Youth Programs

In Y5, SCIC's annual Generating Momentum Youth Leadership and Actvist Training Camp was held in partnership with Regina Public Interest Group (RPIRG) in person August 24-27, 2023 at Station 20 and Wanuskewin (Saskatoon, Treaty 6 Lands). 2023's Generating Momentum's agenda saw youth participants engage in leadership development workshops that focused UN SDG training, community engagement through artistic practice, international development initiatives centered on peace and security, and Justice in Theory and Practice from a local and international perspective.



SCIC's youth programming is deeply rooted in offering meaningful participation opportunities for young people to engage with issues they're passionate about, to develop leadership and global citizenship skills, and to feel empowered to make change locally and globally.

Some highlights of youth programming, include:

- UofR Global Cafe: International Development & Journalism in Warzones
- USask Global Cafe: Climate Action for Peace
- UN SDG Multiplier Training
- Women in Agriculture in Saskatchewan and Beyond
- ACT4SDGs Fast Fashion: Film Screening & Youth Panel Discussion





To summarize, SCIC's youth initiatives in 2023–2024 have made a significant impact, providing Saskatchewan youth with the tools and opportunities to become catalysts for change. By engaging with pressing global issues and cultivating essential skills, SCIC's youth programming has not only inspired but also equipped Saskatchewan youth with the confidence to drive meaningful change. The ripple effect of their awareness, knowledge, and therefore empowered actions is felt both locally and globally, underscoring the important influence of SCIC's commitment to nurturing the next generation of change-makers.

National Coalition

SCIC engaged in active participation and collaborative work as part of the Inter-Council Network (ICN), including chairing the ICN Youth Delegation Committee, and International Development Week Committee, and participating on the SPUR Change, ICN Management and the Monitoring, Evaluation and Learning Committee. SCIC also participated in Cooperation Canada's Board of Directors and their respective Finance & Audit Committee. SCIC supported the development and delivery of the ICN's Youth Delegation Program for youth from coast-to-coast, supported implementation of pan Canadian IDW activities, participated in the collective design on the Public Engagement Framework, and supported the setting of collective direction and coordinated sector advocacy across provincial and regional councils. SCIC was present at the 68th Annual United Nations Status on the Commission of Women (CSW68), and continues to be a strong partner in amplifying Saskatchewan's voice as part of national discussion.

Global Citizen Awards 2024 & 50th Anniversary Celebration

The SCIC's Global Citizen Awards Gala celebrated the 50th anniversary of SCIC, highlighting the exceptional achievements of multiple nominees and three award winners, all making a significant impact in Saskatchewan and worldwide. Library Campaign


As part of the IDW Library Campaign, 495 packages containing reading lists, documentary lists, SDG posters, and postcards were mailed to schools, with additional packages sent to community libraries. Libraries were encouraged to display the materials and participate in activities, with prizes awarded for showcasing the materials and student reading reflections. This campaign aimed to transform libraries into hubs of international understanding and knowledge, culminating in eight libraries receiving two global citizenship books and additional surprises!



Classroom Art Contest

The International Development Week Classroom Art Contest, invited Saskatchewan classrooms to create art around the theme "Under the Same Sky." Packages were sent to 495 schools, and 66 students from six classrooms in five schools participated. We were pleased to congratulations Mr. Stevenson's Grade 1 class at Creighton Community School for winning with their inspiring piece highlighting diverse abilities, including a meaningful discussion sparked by an accidental scissor mishap.


He Named Me Malala Film Screening and Panel






Stories of Impact

Melanie Wilkinson

SCIC has made a significant impact on students at École Silverspring School, through the efforts of teacher Melanie Wilkinson. In Y5, Melanie took part in many of the workshops that SCIC had on offer and used a variety of SCIC resources in her classes. As an educator, the resources and support that Melanie has received from SCIC has made her feel that she wasn't alone and have helped give her support in bringing these topics into her classroom and school. She also was previously struggling to find resources for her Social Studies classes and now she is able to use the GCE modules as a baseline and complete almost all the units with the material. For her students, they are now able to see the big picture of what is happening. This helps create a bigger sense of global issues and instills in the students a sense of what they can do to work towards them.



Stories of Impact

Kaitlyn Kitzan

Saskatchewan youth delegate Kaitlyn Kitzan represented SCIC at the 68th Annual Commission on the Status of Women (CSW68) in March 2024, the UN's largest event on gender equality and women's empowerment. Reflecting on her selection, Kaitlyn said, "I am honoured to have been chosen as a Saskatchewan delegate for CSW 2024. My commitment to advancing gender equality lies particularly within the agriculture industry and the world of politics. I'm looking forward to connecting with other delegates from across the globe to discuss barriers and solutions impacting rural women." SCIC's support for Kaitlyn at CSW68 significantly boosted her advocacy efforts, especially in agriculture and politics. This experience deepened her commitment to feminist action, leading her to host a "Women in Agriculture" workshop in Saskatchewan, which demonstrated her enhanced understanding of the Feminist International Assistance Policy and aligned with SCIC's vision of empowering youth for equitable development.

Abraham Bugre

In Year 5, SCIC was proud to send a youth delegate, Abraham Bugre, to the 28th session of the Conference of the Parties (COP28) at the UN Framework Convention on Climate Change (UNFCCC) in Expo City, Dubai, with SCIC's support. This opportunity facilitated his development and knowledge sharing in the field of climate change research. As a passionate youth climate change consultant and a PhD student at the University of Regina, Abraham's research focuses on the impact of climate change on female farmers in Ghana. He actively advocates for youth inclusion in UN policy processes, playing a significant role in the international youth climate space. Abraham's dedication to promoting youth involvement in the global environmental and developmental agenda is at the core of his work. SCIC was delighted to support such an engaged and dynamic youth representative at this high-profile international sustainability event.

INDEPENDENT AUDITOR'S REPORT

To the Directors of Saskatchewan Council for International Co-operation

Opinion

We have audited the financial statements of Saskatchewan Council for International Co-operation (the "Council"), which comprise the statement of financial position as at March 31, 2024, and the statements of operations, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Council as at March 31, 2024, and the results of its operations and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Council in accordance with ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other Matter

The financial statements for the year ended March 31, 2023 were audited by another auditor who expressed an unmodified opinion on those financial statements on June 28, 2023.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Council's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Council or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Council's financial reporting process.

Independent Auditor's Report to the Directors of Saskatchewan Council for International Co-operation (continued)

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud
 or error, design and perform audit procedures responsive to those risks, and obtain audit evidence
 that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material
 misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve
 collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures
 that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the
 effectiveness of the Council's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Council's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Council to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the
 disclosures, and whether the financial statements represent the underlying transactions and events in
 a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
